Now's your chance Labour!

While we celebrate the demise of 14 years of Tory Government we need to prepare for a persistent struggle to push Labour to take anything like bold action on Social Care. It doesn't bode well that despite their only concrete promise on social care being to improve wages and conditions for care workers, they have scrapped the £53.9m adult social care training and development fund announced by the Conservatives as well as the proposed cap on costs for residential care.

The task is huge while Labour is wedded to two neo-liberal doctrines which the rich and powerful have worked very hard to pass off as common sense. One is the that making money for a small elite is the only hope of creating trickle down wealth for the many, even though it patently doesn't work. Recent research by Oxfam exposed the fact that the world's five richest men have more than doubled their fortunes to £681bn since 2020, while the world's poorest 60% – almost 5 billion people – have lost money !

The other common 'nonsense' is that the national economy works like a household budget. You don't have to go the whole hog with modern monetary theory to appreciate what Keynes said in 1942: "anything we can actually do, we can afford". Just look at how the NHS, education and social security systems were set up after the Second World War, when public debt was at 270% of GDP, and how the Labour Government magically located £137bn to bail out the banks in 2008. The money can be found. What is needed is the political will.

We need to harness all the support we can from allies in Labour, as well as the Greens and Lib Dems. At the same time we need to build up a head of steam from the grassroots calling for radical change, which John McDonnell supported

We also need to debunk the notion that social care is a minority concern not a universal necessity like the NHS. The Department for Work and Pensions Family Resources Survey noted that 24% of the UK population, or 16 million people, had a disability in the 2021/22 financial year. Official estimates of the number of carers are over 5 million but Carers UK estimates that there are over 10 million. If you add 1.6m care workers, that is 28 million people – more than half the adult population – with family members, neighbours and friends also affected and numbers set to rise.

Stand up to racism: Stand by care workers

New RCN data has revealed a six-fold increase in the number of overseas care workers being exploited by rogue employers in the past three years. RCN General Secretary and Chief Executive Professor Nicola Ranger said: "The exploitation being allowed to spread is deeply inhumane and undermines the entire social care sector. Faced with our evidence, ministers were right to commit to an investigation during the election campaign and this must now happen with urgency. Lives are being destroyed every day and this cannot wait. We need action to protect our migrant care workers and raise standards in the sector."

In the light of recent racist riots, stoked by the far right but seeded by years of scapegoating of immigrants by the Tory Government we need to relentlessly expose the myths that feed racism, stand up and defend those who are under attack. Many of the third of health workers and fifth of care workers from abroad who are the backbone of health and care services are even more fearful.

Labour has promised an investigation into the exploitation of care workers from abroad but has said nothing about lifting the recent restriction which stops care workers bringing their children to the UK or urgent changes to the visa system.

Drop plans to cut benefits

Sadly this doesn't just mean Tory plans to change the work capability assessment, impose tougher sanctions on those deemed not to be doing enough to find work, limiting PIP and looking at one off grants and vouchers instead! Now we have to add in Labour's own plans to continue down the same tracks by cutting the winter fuel allowance to older people and refusing to drop the two child cap on child benefit!

The National Pensioners convention, Age UK, Independent Age, Unite, DPAC and many others are resisting the withdrawal of the winter fuel allowance. This will cut support to up to 2 million older people, increase suffering and anxiety, add to hospital admissions and premature deaths.

Please join the resistance, starting with pushing this petition over the 500,000 mark.

Also email your MP to ask them to vote against the withdrawal of the winter fuel allowance in the Commons next Tuesday 10th Sept. You might remind them that MPs can claim allowances for heating their 2nd homes. The bill amounted to over £1m in the last 5 years!

And look out for action at Labour Conference, events round the country on Older People's Day 1st October and an NPC lobby of Parliament from 1pm on 7th October.

Meanwhile, let's celebrate small wins.

Well done to the Disability Poverty Alliance whose well evidenced lobbying was part of the push that led to the Government deciding to extend the Household Support Fund for 6 months at least.
